Contract Duration and Automatic Renewal: Contract is valid and binding for 3 months from the Contract Start Date, and shall be automatically extended for subsequent months on a monthly basis unless terminated by **(Client's Full Name)** via written notice of such termination to Align Ballet Method at least 30 days prior to the next billing date.

Agreement to Pay Recurring Fees: **(Client's Full Name)** shall pay to Align Ballet Method monthly recurring fees as follows:

By signing this Agreement, **(Client's Full Name)** hereby agrees to all of the terms set forth herein above and below:

(a) I shall pay for the **(Name of AutoPay Item)** for **(Amount of AutoPay)**, as an automatic charge to my credit card, or automatic debit to my checking account each month for a contract period of 3 months.

(b) I hereby certify that I am the holder of the credit card or an authorized signatory on the checking account set forth herein below.

(c) I expressly acknowledge, accept and agree that I will be notified if my credit card or checking account payment fails to authorize for any reason and that Align Ballet Method shall charge me a ten U.S. Dollars (\$10) late fee if I do not provide a valid credit card or checking account ACH information within 10 calendar days of the original rejection date.

(d) I expressly acknowledge, accept and agree that Align Ballet Method may deactivate its service to me if my account becomes more than 30 calendar days

(e) I expressly acknowledge, accept and agree that class credits that I pay for may be used for any open Align Ballet Method class or used to drop into a workshop that has available space if I have previously completed the required level of workshop in order to take part in such workshop.

(f) I expressly acknowledge, accept and agree that my membership credits must be used during the 30 days immediately following my purchase of such credits, or such credits become deactivated and may not be redeemed for classes or workshops. I expressly acknowledge, accept and agree that unused membership credits do not accumulate over time.

(g) I expressly acknowledge, accept and agree that my membership commitment is for a minimum of three months. Further, I expressly acknowledge, accept and agree that only subsequent to the initial three billing cycles may I cancel future billing with the Align Ballet Method by sending written notice to Align Ballet at the following email address: Contact@AlignBalletMethod.com at least 30 days prior

to the commencement of the next billing cycle. If I do not receive a confirmation email, I will call Align Ballet Method at: 323-863-5501

(h) I expressly acknowledge, accept and agree that my membership with Align Ballet Method is non-transferable.

(i) I understand that I may temporarily freeze the autopay billing for Align Ballet Method only once per every 12 months for a fee of \$15. (j) I expressly acknowledge, accept and agree that class package credits expire 365 days subsequent to my first visit to an Align Ballet Method class or workshop. I fully understand that Align Ballet Method shall not extend the duration of such class package credits.
